



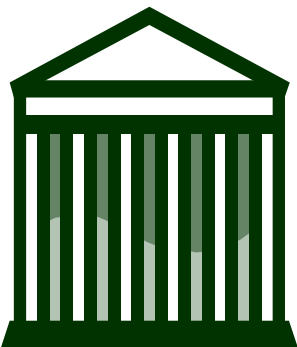

**NEWS ITEMS**

**Important  
Dates**

Every year the Department receives calls regarding the due dates for various filings by licensees. So, to help you out, the following is a list of important dates to remember:

**FEBRUARY**

Annual license renewal notices are sent out in February and applications must be completed no later than **April 1st**. Any renewals received after April 1st will be subject to a \$300 late fee plus the annual renewal fee and will be worked as time permits. Keep in mind that during the renewal period the Department still receives new applications and these must also be reviewed in a timely manner, so renewals that are not received by the due date (April 1st) are second priority at this time.

**MARCH 1ST**

The 6.50 "per loan fees" for period July 1st - December 31st due in to the Department.

## IMPORTANT DATES

(Continued from Page 1)

### APRIL 1<sup>ST</sup>

Annual License renewal applications due in to the Department.

### JUNE 1<sup>ST</sup>

Surety Bond cancellation / non-renewal are notices due to the Department. These are submitted by the bonding companies to the Department. Failure by the licensee to renew the bond will result in the expiration of their license.

### MID-JUNE

Annual licenses that are approved for renewal for the coming year will be mailed beginning mid-June and continue through the end of June.

### JULY 1<sup>ST</sup>

Licenses that were not renewed for the coming year will expire on this date and those former licensees must cease doing business on Georgia residential properties.

### SEPTEMBER 1<sup>ST</sup>

The 6.50 "per loan fees" for period January 1<sup>st</sup> - June 30<sup>th</sup> due in to Department.

### APRIL 1 TO MARCH 31 (Year to Year)

Brokers must obtain continuing education each year in order to renew their license between the dates noted above in order to renew and to avoid fines.

## Required Notices

Along with the important due dates, it should be noted that often licensees forget to inform the Department regarding activity that is required to be reported to the Department. Therefore, the following is a list of the most under-reported and oft forgotten reportable activity that licensees must apply for approval for or report to the Department. Note that **specifics** regarding the changes are in the Code sections.

- ◆ Changes in Principal Officer(s);
- ◆ Changes in Ownership — see O. C. G. A §7-1-1008 for specific details.
- ◆ Changes in office locations—Main Office and/or Approved Branch—due 15 days **BEFORE** the move is made;
- ◆ Changes in registered agent;
- ◆ Changes in mailing address—due **PRIOR TO** the effective date of the move.
- ◆ Name Changes—may involve change in management or control. This includes name changes due to marriage or divorce, which requires filing of a copy of the appropriate legal paperwork;
- ◆ Notice of actions brought against

licensee or judgments against it—due within 30 days legal action commenced or 30 days of entry of the judgment. Some exclusions and restrictions apply—see §7-1-1007 for details.

- ◆ Changes in Directors;
- ◆ Changes in Contact Person.

And it goes without stating that GEORGIA branch offices and their managers **MUST** be approved **BEFORE** they can be opened, so notice (and Department approval) is required **BEFORE** opening any new branch location.

## Other Items

### APPRAISAL CHANGES

The Georgia Real Estate Appraisers Board has amended Chapters 539-1 and 539-3 of its rules (effective August 1, 2006). The new rules establish state standards for appraisals that are much more detailed than those in the past. Information is available on the Commission's web site under NEWS at:
